Short Description

This handbook is the result of six National Societies, the International Federation and the Red Cross/European Union meeting in Copenhagen in 1997 to discuss the importance of strong cooperation between the members of the network of the European Red Cross Societies, sharing their experiences concerning refugees, asylum seekers and migrants this resulted in the creation of the Platform for European Red Cross Cooperation on Refugees, Asylum Seekers and Migrants (PERCO), a trans-national platform involving National Red Cross Societies that aim to improve the work of Red Cross and Red Crescent in assisting displaced and moving people. The guidelines provided by the aforementioned platform is meant to be respected by all European countries withing their socio-economic limits. Great stress was placed on the importance of informing and educating the citizens on the migrants' rights, encouraging them to work in order to have them respected, thus preventing xenophobia and racism.

Short Description

This report in Wales was compiled by the Equality, Local Government and Communities Committee established on June 2016 to inspect legislation regarding refugees and asylum seekers and the adequacy/inadequacy of the Welsh Government's approach in their support – especially regarding how well Wales was responding to the large-scale displacement of Syrians and unaccompanied foreign minors - holding the Welsh Government to account through a series of recommendations, with the final goal to make of Wales a "Nation of Sanctuary" through a series of projects and support group calling to action the population of the whole national territory.
